#### 5. PRESENTATIONS

## 5.1 Jason Vassell, Faculty to present an overview of the Black Student Success Network

# 5.2 Tom Lynch, Director, Campus Safety, Thomas Bezruki, Manager, Emergency Management and Jennifer Cosway, Associate Vice-President, Human Resources to present a Status Update on the Fall Return to Campus and Implementation of the Vaccine Policy

The Director, Campus Safety, the Manager, Emergency Management, and the Associate Vice-President, Human Resources provided an update on the fall return to campus and provided information on rapid testing, the vaccination uptake at the Campus Ice Centre, requests for exemptions, and issues related to the implementation of the COVID-19 vaccination policy.

The Board questioned the Director, Campus Safety, the Manager, Emergency Management, and the Associate Vice-President, Human Resources.

#### 6. CHAIR'S REPORT

The following items were discussed:

- The Chair shared a conversation she had with Lyn McDonnell of the Accountability Group Inc. regarding new sessions at the Higher Education Summit related to asking better questions and developing a strategic mindset. The Chair also reminded Governors about the College's values and the lens through which decisions should be made.
- The Chair asked for volunteers to form a Retreat Planning Committee. Governors' Cowie, Doyle, Johnson Morris, Powell, and Rose agreed to participate.
- The Chair highlighted the upcoming grad sign pick-up events on October 26 and 28.
- Governor Nagpal spoke to the recent student governor workshop he attended.
- Governor Doyle was recognized for receiving her Good Governance certificate.

Governor Ouellette temporarily left and re-joined the meeting.

#### 7.1 Approval of Minutes from the June 9, 2021, Board Meeting

#### 7.4 Program Advisory Committee Semi-Annual Report - October 2021

The Board questioned the Executive Vice-President, Academic, about the status of the Program Advisory Committee's that had a red rating. In response to questions, the Executive Vice-President, Academic, advised that active recruitment is underway to ensure that all Program Advisory Committees comply with By-law No. 2 and membership requirements.

#### 8. DISCUSSION ITEMS

#### 8.1 Update on Plans for Fall Convocation

The Associate Vice-President, Academic (International & Enrolment) presented an update on plans to recognize graduates this fall, including a revised convocation microsite and enhanced grad sign pick-up events. Planned events are responsive to feedback that found graduates did not want to attend a virtual convocation and would prefer to wait for an in-person convocation ceremony.

## 8.2 Domestic and International Enrolment Update - Fall 2021 - Day 10 of Classes

The Associate Vice-President, Academic (International & Enrolment) presented the enrolment numbers for fall 2021 and reported that as of day 10, the College had 10,623 students, of which 8,627 are domestic, and 1,996 are international. Further, the Associate Vice-President, Academic (International & Enrolment) spoke to enrolment numbers and applicant behaviours trends.

The Board questioned the Executive Vice-President, Academic and Associate Vice-President, Academic (International & Enrolment).

#### 8.3 Approval of Permanent Program Suspension: Healthcare Administration

The Executive Vice-President, Academic, provided an overview of the program suspension process. Further, the Dean, School of Professional and Part-Time Learning, advised that St. Lawrence College was the host college (through Ontario Learn) for most of the courses (9 of the 12 courses) in the graduate certificate. Because of low registration numbers, they dropped the claims for these courses. As the course claims are not financially viable, the College recommends that the two courses offered as part of this graduate certificate be permanently suspended.

The Board questioned the Executive Vice-President, Academic, and Dean, School of Professional and Part-Time Learning.

#### 8.4 Government Relations Update - Fall 2021

The Manager, Strategic Reporting and Government Relations, presented a government relations update for fall 2021 and spoke to the recent results of the federal election. Further, the Manager, Strategic Reporting and Government Relations discussed advocacy work related to the Whitby campus and credential reform and shared the new government relations strategy.

Moved By Governor Murray Seconded By Governor Michalko "That Report BOG-2021-59 providing an update on government relations activities for fall 2021, be received for information." CARRIED

#### 8.5 First Business Plan Update for 2021-2022

President Lovisa presented the first business plan update for 2021-2022 and highlighted the key initiatives completed to date.

#### 8.6 Introduction of the Innovation & Disruption Catalyst Group

President Lovisa spoke to a new group at the College known as the Innovation & Disruption Catalyst Group (IDCG), whose mandate is to amplify and start conversations about innovation across all levels of the College. Further, President Lovisa advised the College had launched a Hofstede cultural measurement that will close on October 22, 2021. The results of the survey will inform the future work of the IDCG.

As part of this update, the Board watched a video introducing the Hofstede cultural measurement.

The Board questioned President Lovisa.
