1. CALL TO ORDER

Upon declaration that the Board meeting was duly constituted and with quorum present, the Chair called the meeting to order at 6:00 p.m.

The Chair acknowledged the following guests in attendance: Debby Allbon, Executive Director, Strategic Reporting; Jennifer Cosway, Associate Vice President, Human Resources and Equity; Dr. Sadie Goddard-Durant, Director, Office of Equity, Diversity and Inclusion; Danny Nashman, The Potential Group; Dr. Mojgan Rezvani, Executive Dean, Faculty of Health Sciences, and Tara Koski, Dean, Students.

2. LAND ACKNOWLEDGEMENT

Governor Bosomworth offered the land acknowledgement.

3. CONFLICT OF INTEREST DECLARATIONS

The Chair asked if there were any conflicts of interest to declare. None noted.

4. PRESENTATIONS

4.1 Danny Nashman from The Potential Group to present emerging themes from the strategic plan consultations

The Board received a presentation from Danny Nashman at The Potential Group regarding emerging themes from the strategic plan consultations and upcoming visioning sessions, which will bring groups together to discuss a specific topic.

Governor Chakravarthy temporarily left and re-entered the meeting.

The Board questioned the presenter regarding the methodology for selecting the session topics, the target audience for the sessions, whether Governor participation was encouraged, and why certain sessions were only being offered at the Oshawa location.

Action: The Board Secretary to provide the Board with a list of session dates and details on how to register.

5. CONSENT AGENDA

5.1 Approval of Public Session Agenda - December 11, 2024

5.3 Report of the Governance Review Committee - November 4, 2024

6. CHAIR'S REPORT

The Chair reported on the following items:

- A partnership with Durham College and Ontario Power Generation to launch an Introduction to Millwright program to support Indigenous learners. Governor Brown spoke about the specifics of the program and the benefits to the community.
- The College's open house on November 9, 2024, saw over 2500 registrants and the submission of approximately 700 applications. Governor Pryce remarked about his experience at the Whitby Campus.
- Governors who attended the Higher Education Summit reflected on the experience.

7. CO-POPULOUS GOVERNORS' REPORT

There was no co-populous Governors' report.

8. DECISION ITEMS

8.1 New Program of Instruction: Bachelor of Paramedicine (3-Year)

The Board received a report from the Vice President, Academic and Students and Executive Dean, Health Sciences, presenting a new program of instruction for approval, Bachelor of Paramedicine. Specific to this program proposal, the Vice President, Academic and Students advised the move to a 3-year degree program was a sector-wide collaboration to advance system-wide transformation in the paramedicine field. Further, it was reported by the presenters that the

College would only offer the program if it was approved by the Ministry of Health and the Ministry of Colleges and Universities. The program, if approved, is designed to prepare graduates for entry to practice in the paramedic field and includes 584 hours of combined experiential learning and professional practicums.

The Board questioned the Vice President, Academic and Students and Executive Dean, Faculty of Health Sciences regarding the rationale and need for the third year of study, the financial impact and contribution of the program, whether the program would be on the IRCC list of approved programs, and if there were any opportunities for partnership to fund the program given the demand from local municipalities for paramedicine students.

9. DISCUSSION ITEMS

9.1 Sexual Violence and Harassment Action Plan Annual Report

The Board received a report from the Associate Vice President, Human Resources and Equity and the Director, Office of Equity, Diversity and Inclusion, presenting the sexual violence harassment action plan annual report. The report detailed the number of formal and informal reports received, the prevention and education initiatives that the College provides, and a review of supports available to victims of sexual violence.

The Board questioned the Associate Vice President, Human Resources and Equity and the Director, Office of Equity, Diversity and Inclusion regarding the effectiveness of the PREP1000 courses offered to students, the investigative process if informal complaints are reported that may have a broader campus safety implication, and whether there was data to provide a more holistic picture of the individuals reporting (e.g., full-time, part-time, primary campus). In response to questions, the presenters advised they are currently working on creating a database to collect additional information from victims and that where a safety concern is identified, they work closely with the Office of Campus Safety; however, the process is driven mainly by the wishes of the individual reporting the incident.

9.2 Update on the College's Social Commitments

The Board received a report from the Vice President, People, Equity and External Relations and Executive Director, Strategic Reporting, presenting an update on the College's efforts to advance its social commitments, including the Dimensions Charter, Indigenous Education Protocol, and the Sustainable Development Goals Accord.

The Board questioned the Vice President, People, Equity and External Relations and the Executive Director, Strategic Reporting, whether there was data to suggest these commitments have a tangible benefit to students, if there were membership fees associated with being a signatory to these commitments, and what the College was doing in place of supporting the Black North Initiative.

In response to questions, the Associate Vice President, Enrolment and International Education advised that being a signatory to the Sustainable Development Goals Accord was a competitive advantage to receive funding from CICan for some international projects and international partners.

9.3 Indigenization Efforts at Durham College

The Board received a report from the Vice President, Academic and Students and the Dean, Students presenting an update on the Durham College Indigenization Council's work in meeting the Indigenous Education Protocol requirements. The report highlighted various initiatives, including events, days of significance, efforts to Indigenize curriculum and a new Indigenous Student Authentication project to assess with processes such as awarding student bursaries and donor awards.

The following item was presented for information only:

10.1 President's Update - October to December 2024

The Board questioned the outcomes of the political meetings noted in the President's update. In response to questions, the President advised she would provide specific details about her political outreach in the in-camera session.

11. UPCOMING EVENTS

The Chair drew attention to the following upcoming events:

- The current call for donations to the Food Access Bursary, noting that donations made before January 1, 2025, will be matched by the Durham College Alumni Association up to \$10K;
- The campus closure from December 24, 2024 to January 1, 2025; and,
- The upcoming Board Learn More Session about Corporate Training Services on January 7, 2025, at 5:30 p.m. via MS Teams.

12. MOVE TO IN-CAMERA SESSION
