MESSAGE FROM THE EXECUTIVE DEAN

The completion of the 2017-2018 academic year has resulted in the achievement of a number of accomplishments. Durham College completed its participation in the College Quality Assurance Audit Process which is a provincial framework to assure quality in Ontario community colleges. During the audit, six programs from DC were examined in detail, and the School of Justice and Emergency Services was selected to have two of its programs participate. We are awaiting the results of the audit, but found the process to be enriching and validating.

Durham College has also witnessed the construction of another new building: the Centre for Collaborative Education (CfCE). This building will replace the Simcoe Building which has been a landmark for all students who have attended DC. The "old" Simcoe Building will be demolished at some point this year, ending an era. The CfCE will house new laboratories for our science courses, the new Global Classroom, the Massage Therapy Program, and a variety of other uniquely designed spaces. The building will be open for use in September of this year and we are looking forward to opportunities to use the space for student engagement and for hosting the community.

Aside from the broader college updates, it is great to see the success that our law clerk graduates are enjoying in obtaining positions. The Law Clerk Advanced program continues to enjoy success in the quality of the program and in the quality of our graduates.

IN SEARCH OF TECHNOLOGY...AND PURA VIDA!

I have been teaching at Durham College for 16 years. As most alumni know, I have been teaching Office Procedures and Accounting for most of that time. It always seemed that I was getting information from HR specialists who weren't actually doing the law clerk/legal assistant job, or information from new hires who were not sure how it all fit together. Most of my driving epiphanies are -- what is for dinner or where is my next vacation - but this time it was computer curriculum. I know it may not be the most exciting topic, but it was obviously something that had been rattling around in my teacher brain!

I decided I must venture back into the legal environment to find out for myself. This journey started out as a meeting with our dean Stephanie Ball and then blossomed into a sabbatical for one semester. This is officially called a Professional Development Leave. Since I had not worked in a law firm for 16 years, it was time to go back and find out how office procedures had changed due to technology and what software law firms were using.

My PD leave started in January 2018 for one semester. The nice thing about taking a PD leave in the winter is the opportunity to take some vacation time in January, so of course, that's where I started. My husband and I spent a few weeks in Costa Rica with family members. As anyone who knows me will tell you, Costa Rica is my go to place and my passion. I love to discuss this beautiful country with anyone who wants to listen. Pura Vida is what motivates me!

After some rest and relaxation, I returned to the cold north to venture back into the legal environment. My first visit was to Goodmans LLP in downtown Toronto. They brought me in as a new hire and put me through a few days of their onboard training sessions. I arrived on a Monday morning at 9:00 a.m. with four other new hires who were all in their early twenties. I am sure that as they sat in the reception room that morning looking around at the other candidates, they were surprised to find that Goodmans hired such "old" people...or maybe they were glad to see the diversity! They all welcomed me with open arms and provided me with some wonderful knowledge about office procedures, hiring processes and a good picture of what software is presently being used in the field. WHAT DID I LEARN?

The struggle to stay up to date with software will always continue. All firms were using something a little different and each area of law has its own specialized software. In my mind, the best education we can give our students is strong basic skills in all areas. All firms use Microsoft Office products and students must be comfortable with Word and Outlook at an advanced level. All firms agreed that they do not expect the college to provide training in every software, but if students have strong computer and keyboarding skills, they can train them on the rest.

As a result, I have been able to make some changes to the computer courses. I researched some new software - Infoware/Word LX, WordShare and ULaw, and in the fall, I will introduce this software in some courses.

This PD leave has been a great experience and one that leaves me satisfied that I have done the proper research to develop our computer courses to meet the needs of the legal environment. I am excited to introduce some new software to our students in the fall.

The Durham College attendees included Darla Weir, Virginia Harwood and Lesley Wagner. Each attendee enjoyed an opportunity to discuss new legal practice supports, practice tips and updates to legislation during their four days in Ottawa.

The 2018 ILCO conference theme "Commitment to Excellence – 50 Years" offered those in attendance a wide range of concurrent sessions across all legal disciplines including family law, estates, intellectual property, corporate, litigation, and real estate.

The conference keynote speakers were:

ALUMNI PROFILE: VICTORIA ROBINSON LAW CLERK ADVANCED FAST-TRACK GRADUATE

ENTRY LEVEL OR ENTRANCE TO OPPORTUNITY

I began my legal journey by enrolling in the Paralegal Diploma program, where I gained the knowledge and practical skills required to provide legal services in a wide range of legal areas. With the knowledge gained through the Paralegal program, the opportunity to take the Law Clerk Advanced Fast-Track program was a no-brainer for me. Being able to obtain a second Diploma in 3 semesters was one of the best decisions I have made to further advance myself in a career

During my final weeks of school, I had several interviews for different companies and was fortunate enough to have been extended offers by more than one company. It was then I realized that my Paralegal and Law Clerk Diplomas had given me a step ahead in the legal industry. It was also then I realized I had to make the decision of which offer would be most beneficial to me.

Days following my final exam, I began my career at Osler, Hoskin & Harcourt LLP; a seven-sister business leading law firm. No, I didn't start my Law Clerk career days after my final exam, and I will be the first to admit I was a little disappointed. I felt as though my schooling was going to go to waste and I was never going to be given the chance to practice as a Law Clerk. Do I still feel disappointed to this day? Absolutely not!

I began at Osler as a Legal Secretarial Assistant (Document Support) in May 2017. This position entails supporting an entire department with overflow work such as formatting legal documents, assembling closing books and court documents and troubleshooting technological issues. A short three months later, I pursued an opportunity to work as a Legal Secretarial Assistant in the Banking & Financial Services department. I was given the opportunity to work for a Partner and three Associates. The confidence the lawyers had in me allowed me to work much more closely in their transactions as opposed to strictly legal administrative support work. Throughout my time working with these lawyers, I learned to love Banking and Corporate law. I gained so many transferable skills that have benefited me to this day and will continue to benefit me throughout my career.

I came across a Law Clerk opportunity at BMO Financial Group in the Subsidiary Governance Office in April 2018. With my grown love for Banking and Corporate law and my drive to become a Law Clerk, I thought to myself, 'there's no harm in applying, just do it!' After multiple interviews, I was offered (and accepted) the position! A lot of people ask, what is the Subsidiary Governance Office, and what is your role as a Law Clerk? How do you tie into the bank? The Subsidiary Governance Office is part of the Corporate Secretary's Department. We implement governance functions for the Bank of Montreal and its 195 current subsidiaries in 16 jurisdictions. Working with multiple companies in different jurisdictions gives me the opportunity to learn daily, which is one of the things I love most about this kind of work. I work directly with Corporate Secretaries, General Counsels and Executives in diverse departments of the Bank to support the boards of directors. My responsibilities have drastically changed as I now own my own work stream. Drafting corporate documents, up-keeping Minute Books, and jurisdictional filings are some of my day-to-day responsibilities.

Did I love working in a law firm? Yes. Do I love working in-house? Yes. Don't feel because you want to work in the legal field, you are limited to law firms. Working in-house has exposed me to so much that I wouldn't have been able to do in a law firm setting. My biggest piece of advice - don't be disappointed with an entry level position (it's how you learn), take on extra responsibilities, build a strong professional network and work your way up. You never know where your career will take you. Oh, and don't be surprised when you realize the legal world is nothing like Suits!
